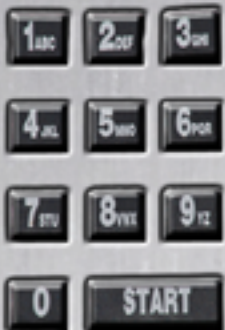

In this issue, we address a commonly found item throughout the galaxy: Universal Polymer Base. UPB's are handy materials, able to be configured into myriad forms, but your average sentient lacks an easy means to make use of them. Until now.

The Flash Fabricator. A staple device of Quantech United, their Fabricator is a fabulous bit of technology that can make anything your heart desires, so long as you have the right schematic of course!

Fabricator technology comes in a variety of sizes and uses. Though models may vary, all of them have the same cores. These 'nanocores' are the heart of fabrication technology, allowing it to take your UPBs and make it into pretty much anything. Every fabricator comes with the entire Quantech United basic parts catalog pre-installed, so don't you worry about not having the programming skills to fabricate the basic parts or tools you need to repair your ship or that leaky airlock seal!

The system uses high-speed nanobot construction and control system. The nanocore takes polymer base from the material feed and generates hundreds of thousands of nanobots (nanites) a second. The nanites move to the simple, preprogrammed arrangement as per the schematic the nanocore is following and fuses with all adjacent nanites. If enough polymer base is available, a single fabricator unit can generate an item in just a few seconds. Fabricators use incredibly fast, but exceedingly simple nanites that are only capable of following pre-programmed designs. It is also capable of converting most petrochemicals out of plastics, allowing it to fabricate simple fuel, coolant, or ammunition for many devices.

In addition, Quantech United has recently revealed their organic fabricators, which take base proteins and carbohydrates from an organic material tank. These nanocores generate organic nanites, which are also completely edible. Carrying base materials with them when they fuse, the entire meal made by a fabricator is composed of ready-to-eat organic material (note: that the fusing process destroys any functionality of the nanites). Organic processing is completely safe to eat, and can be used to make fresh meals with no risk. It should be noted that the organic fabricator can also be used to construct or assemble things that look like life forms, but they would only share the appearance of the object. No life is instilled into a fabricated organic body (if a customer should purchase a large enough organic fabricator to make one, that is). Using a DNA template, an organic fabricator can even create replacement organs or body parts (attachment still required by a medical professional, consult your doctor before use).

Additionally, there are 'dual-core' fabricators that have both nanocores installed, but they are considered military hardware and are not available for commercial purchase.

What does this mean?

Magitech Monthly is split into two parts, one half is entirely in-character for the setting, and the other half contains the nitty-gritty mechanical bits and bobs that make the things work behind the scenes. Anything captured in one of these text windows is strictly out-of-character information!

Installation: Flash Fabricators can be installed in a starship as an extra system. Starship Flash Fabricators take a variable amount of PCU (but only 2 BP) to install. When installed, the crew may select the amount of PCU assigned to it, in increments of 2 (maximum 10). A dual-core Flash Fabricator can be installed on starships of Medium size or larger.

Upgrade a System: A single-core Flash Fabricator can be installed into a medical bay, synthesis bay, or tech lab, instead upgrading that system without using another expansion bay. Done this way, the Flash Fabricator only produces materials for the system it upgrades and cannot be used to manufacture repair parts like a dual-core system can. Installing a single-core Flash Fabricator increases the PCU cost of the upgraded system by 2 and the BP by 1.

Operation: The Flash Fabricator can convert UPBs into the materials needed to operate the medical bay, synthesis bay, or tech workshop systems, as well as components required to repair any purely technological item or starship. The amount of UPBs required for fabricating a given item is equal to half the object's price in credits. Repairs require the full cost of repair materials without modifiers in credits. A flash fabricator produces 100 x the number of PCU assigned credits worth of work a round.

Purchasing Schematics: Item schematics for fabrication can be purchased off the infosphere, typically at a cost of 100xitem level credits, though prices can increase as much as 100% depending on the rarity of the item desired.

A dual-core fabricator can fabricate anything that it has both the schematics and materials for.*

Additional upgrades available include the bulk feed hopper, increased storage capacity and the advanced product schematic DLC!

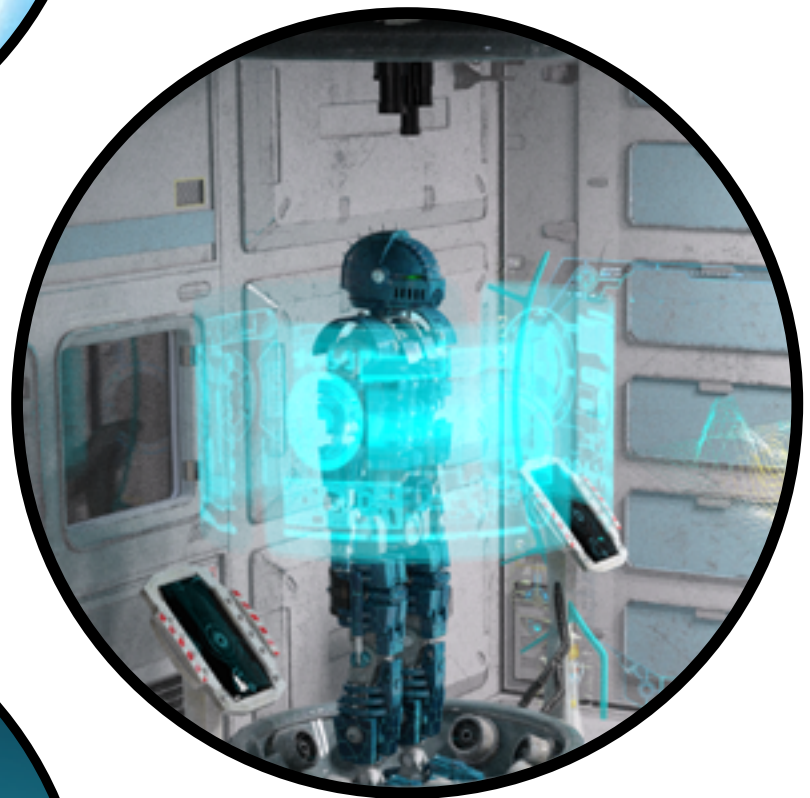
